WE HAVE A NEW WALK-THRU REGISTRATION PROCESS - PLEASE READ CAREFULLY!

It is essential that the following procedures are followed:

- 1. A parent or legal guardian must be present with their student(s). Students will **NOT** be able to attend without a parent/guardian.
- All forms and personal information must be updated electronically by parent(s).
- You will need an active Parent Portal account to access forms and personal information. If you
 have not created a parent portal account please go to www.luhsd.net/parentportal for
 instructions on how to create an account.
 - ✓ Log onto your Parent Portal Account at http://parents.luhsd.net
 - ✓ Sign all forms electronically
 - ✓ Update all personal information including emergency contacts
 - ✓ Complete and print out a copy of your student's Emergency Form and bring with you to "Walk-Thru"
- 4. Please bring your photo ID plus 2 forms of residence verification. Residency verification is still required even if there is an older sibling at Freedom. YOU WILL NOT BE ABLE TO ATTEND WALK-THRU WITHOUT PROOF OF RESIDENCE.

Students will be required to take their photo for student ID card and yearbook at Walk-Thru. School dress code applies and students out of compliance will not be able to take ID card/yearbook photos. Please see our dress code requirements in the students handbook online.
