Dear Parents and Students:

WE HAVE A NEW WALK-THRU REGISTRATION PROCESS- PLEASE READ CAREFULLY!

It is essential that the following procedures are followed:

- 1. A parent or legal guardian must be present with their student(s). Students will **NOT** be able to attend without a parent/guardian.
- 2. In order to attend Walk-Thru, all fines **MUST** be paid and all textbooks/library books turned in. Summer hours to settle fines and return books are July 10 - July 14, from 8:00am - 3:30pm.
- 3. Create a Parent Portal Account. Go to http://www.luhsd.net/parentportal for instructions on how to create a Parent Portal account. YOU MUST BRING a printout of the Emergency Card to Walk-Thru. Computers and printers will be available at Walk-Thru, if needed.
- 4. Students will be required to take their picture for their student ID card and Yearbook during Walk-Thru; Dress appropriately.

The portal will be open beginning July 3rd

Freedom High School's Walk-Thru registration is a MANDATORY event for students and at least one parent or guardian. This is not a first-come, first-served event and our experience has been that the lines are shorter later in the day. Please refer to the schedule below regarding your student's Walk-Thru date. If you have multiple students, you may attend either of your students' assigned days and complete registration in the same visit.
