## WALK-THRU REGISTRATION PROCESS - PLEASE READ CAREFULLY!

It is essential that the following procedures are followed:

1. **PARENT PORTAL ACCOUNT** must be active to access forms and personal information. If you already have an account, proceed to number 2. If you do NOT have a Parent Portal Account, an email will arrive in the first week of July from "do-not-reply-aeries@luhsd.net" with instructions to create your account. If you do NOT have an email, please contact Gina Bills, Registrar, (925)625-5900 x3004.
2. **LOG ONTO YOUR PARENT PORTAL ACCOUNT:**
  - ✓ Sign all forms electronically
  - ✓ Update all personal information, emergency contacts and medical history
  - ✓ Review documents and authorizations
  - ✓ **Complete, print, and bring a signed copy of your student's Emergency Form with you to "Walk-Thru"**
3. **PARENT OR LEGAL GUARDIAN** must be present with their student(s). Students will **NOT** be able to attend without a parent/guardian.
4. **FINES AND FEES** must be paid and all textbooks/library books turned in, in order to attend Walk-Thru. Summer hours to settle fines and return books are July 10-13 from 8am-3pm.
5. **PROOF OF RESIDENCY** verification (2 forms) plus photo ID are required (requirements attached). Residency verification is still required for all incoming 9<sup>th</sup> grade students even if there is an older sibling at Freedom. **YOU WILL NOT BE ABLE TO ATTEND WALK-THRU WITHOUT PROOF OF RESIDENCE.**
6. **STUDENT ID and yearbook photos will be taken at Walk-Thru.** School dress code applies and students out of compliance will not be able to take ID card/yearbook photos. Please see our dress code requirements in the student handbook online.
