New Business:

Jeni Groseclose informs council that she is taping the meeting- unanimous consent.

3:39 Shelly Johnson welcomes council, Roll call is taken.

3:45: Shelly Johnson begins meeting with explaining the **Uniform Complaint Policy**

- The purpose, process and requirements: Harassment, discrimination, lack of instructional materials, teacher issues, emergency facility issues etc. - ANYONE can fill out a complaint form (Staff, student, parent etc)
 1. Assistant Principal reviews, **must** investigate (**mandated**), determines next steps.
 2. Chain of concern: AP, Principal, Superintendent, LUHSD School Board
 3. All relevant documents are in both English and Spanish.
 4. Parent incident reports are located in the Attendance office.
 5. All information about the Uniform Complaint policy is on the website.
- During this discussion Sarah Duran and Michelle West requested that the SSC address safety at large Sports events. (Crowds, weapons, rumors etc.) Shelly advised for parents to contact their students' AP to gain information about how safety situations such as those are handled and supported.
- Shelly uses a power point to share **Attendance Achievement Data**.
 1. State average attendance is 91.77%, Liberty's is 95.76%
 2. We are working hard to help kids understand the importance of good attendance and have consequences in place. (Restore time)
- Power point presentation and light discussion of the **School Climate Report Card**. This data comes from the California Healthy Kids survey given in 5th, 7th, 9th and 11th grades. Parents are notified and have an 'opt out' if wanted. Council given 7 minutes to peruse the report.
 1. We don't have the 23-24 Data yet
 2. Survey is complicated and very subjective
 3. State gives us the survey and analyzes the data
 4. Good (but incomplete due to lack of interest) source of data to help determine areas that need

improvement. SPSA information.

5. SWANS (Students with additional needs). Goal is Equity: no matter where a student starts out they have the same opportunity to succeed. This is achieved by different programs throughout the school. ELD, support classes, etc.
6. In the spirit of transparency-out CAASSP scores did go down this last year. Data is in and will be reviewed along with Goal 1 of the SPSA they will be analyzed when we get them and this data will be a part of the SPSA discussions next month.
 - Dante Ross expressed that some of the problem with CAASSP testing is lack of student “buy-in”, there are no rewards for doing well. More discussion is needed on this subject.

Due to time constraints the agenda item ‘SPSA Annual Updates, Review and 2023-24 SPSA and Related Effectiveness Data’ will be moved to the SSC agenda for October 17th meeting. The current SPSA will be sent out via email to SSC members so they can study it.
