### ONLINE PROGRESS (ATTENDANCE):

**Distance Learning (not in-person)** - Because summer courses cover extensive instructional content in a relatively short time period, consistent daily online progress is crucial. **Students who do not participate or show positive progress for more than one day and/or have not completed the entire course may not receive credit for summer session class(es).** - Board Policy / AR 6177

If your student needs a laptop, please arrange to check one out with your home site before the end of the school year. All needs after the school year should come through the Summer School Office.

### PROCEDURES: Parents and Students –

1. Carefully review information for accuracy, communicate with counselor and sign pages 3 and 4.
2. Submit application to your counselor **on or before** the deadline (**\*Exception: Additional course or Spring 2025 courses**).
3. Keep pages 1 and 2 for your reference.

## Imagine Edgenuity and Summer School Program Information

The curriculum offered in all Summer School programs adheres to the school board-mandated LUHSD 9-12<sup>th</sup> grade courses of study and courses are offered through Imagine Edgenuity (Edgenuity) – Math, English, Social Science, Science, and Health.

### Features and Information:

- Common Core Standards-aligned online video-based curriculum where students are required to view the teacher-lead video and may rewind or repeat for clarification as they move through each course unit.
- The program allows educators to customize the curriculum for their students, including modifying or accommodating the needs of students with IEP's and/or 504 Plans.
- Teachers motivate, guide, support and monitor student progress as the student moves through course requirements completing lessons, assessments, and interactive activities. Communication with the student may occur through email or personal contact.
- **In order to complete a credit recovery course (previously failed 5 credit course), a student typically works online for 30 hours.**
- Students may only take one course at a time, and a total of two during the summer program.
- With this model, motivation is the key! **Students are required to actively participate and produce a minimum of 10% daily progress** while doing their very best to pass all activities including quizzes/tests.
- Students earn the "Overall Grade" of the course.
- Showing mastery in the pre-test process will eliminate specific activities and the course will be automatically adjusted (less time needed to complete the course).
- All assessments, including pre-testing are enabled unless there is a teacher concern. If there is a concern, (possible cheating) at any time, including pre-tests, quizzes, etc., the teacher will communicate with my parent, and assignments/assessments may be locked until further resolution.
- **In order to earn credit, students must complete 100% of the course (including pre-tests).**
- **Courses should be completed within 8-16 days.** Final course completion will be communicated by the teacher.
- Students will access the curriculum via Clever.com / Imagine Edgenuity and **NOT** Canvas. The course begins with an orientation and is followed by video-based instruction.
- Each course uses video and text content and various types of assignments including writing assignments, projects and graded tasks to support different learning styles.
- Again, students are required to work on lessons daily until the course is completed.
- Student and parent must read, sign, and return the Academic Integrity Policy (AIP) with the application (Page 4 - backside of the application)

## Academic Integrity Policy



### I AM AWARE THAT:

- I may only take **one** Imagine Edgenuity (IE) course at a time.
- Teachers will support, guide, and monitor my progress as I move independently through course requirements.
- Teacher Support Office Hours are: Every school day from 8:30 a.m. – 12:30 p.m.
- I may be required to take notes for each lesson. If I do not take notes, I may be required to redo the direct instruction lecture (video instruction).
- I will be given 3 attempts to pass each test. If I do not pass after 3 attempts, I will have to conference with the teacher to either earn another attempt or an alternative assessment.
- If there is a concern with possible cheating at any time, including pre-tests, quizzes, etc., the teacher will communicate with my parent and assignments/assessments may be locked until further resolution.
- I must complete 100% of all required coursework by the target date. If not, a no mark (NM) will be issued.

### I AM COMMITTED TO:

- Turning off (disabling) and putting away my cell phone and/or unauthorized devices while in IE.
- Actively participating and producing a minimum of 10% daily progress along with passing all assignments, quizzes, and tests (60-70% or higher).
- Communicating with the teacher regarding any challenges I have with the assignments or the program.
- Abiding by the district technology acceptable use requirements.

### I PLEDGE THAT I WILL NOT:

- Plagiarize or cheat, including allowing others to do my online work.
- Use websites that provide answers to assignments or assessments.
- Give unauthorized assistance on assessments, or allow others to give me assistance on assessments.
- Have additional sites (windows open) on the computer/laptop other than those determined by IE.
- Use or access any outside resources (including cell phone) during assessments.
- Post assessments/assignments, answers to assessments/assignments, or any other curricular materials on any media that other students or other third parties could view.
