

THREE LETTERS OF RECOMMENDATION Letters of recommendation should be from someone other than a family member or a member of LSI (e.g., long-term family friend, teacher, school counselor, employer or coworker) and should contain the author's relationship to the applicant. Additional items to include in the letter are a description of the applicant's personal traits (character, personality and goals) and the applicant's school or work experience and ethic. Letters should be word processed on 8.5"x11"paper and addressed "To Whom it MayConcern."
