INDEPENDENCE HIGH SCHOOL

- WHO:** Presently enrolled (2020-21) Independence High School students. (9th 10th 11th 12th)
- WHAT:** Courses required for graduation (a-g but not NCAA). Student may enroll in two classes for the summer.

APPLICATION DEADLINE: **April 30, 2021**

2021 LOCATION: Online at home only (or Public Library etc....)

- Daily online assignments and work produced is mandatory (minimum 3 hours per day).
- More than 6 hours missed for any reason may result in dismissal from the program.
- Student online assignments and progress will be monitored with daily support.

2021 SUMMER EDGE PROGRAM (EDGENUITY ONLINE)

We will be using a blended learning opportunity in all courses in hopes to best serve students in need of credit recovery and grade improvement. The curriculum offered in Summer School 2021 adheres to the school board-mandated Liberty Union High School District 9th-12th grade courses of study.

Summer Edge Program (Edgenuity online), Features and Information:

- The courses use audio, video and text content and different types of assignments including writing assignments, projects and graded tasks to support different learning styles.
- Common Core Standards-aligned online video-based curriculum in a blended learning environment with teacher support online.
- The program allows educators to customize the curriculum for their students, including modifying or accommodating the needs of students with IEP's and/or 504 Plans.
- Students access the curriculum via the internet through a computer, laptop or tablet from home, City Library, etc. and begin the program with an orientation and pre-test followed by lecture-style lessons.
- **Showing mastery in the pre-test process will eliminate specific activities and the course will be automatically adjusted (less time needed to complete the course).**
- The Summer School teacher will motivate, guide and monitor student progress as the student moves through course requirements completing lessons, assessments, and interactive activities. **A student typically works online for 30 hours (to complete a 5-credit course).**
- Students should plan their own schedule and may work at any time during the day and evening. The Summer School teacher will monitor student progress during the day 9am-5pm, and is available for **conversations** between the hours of 3pm-5pm.
- Student may complete the course before the session end date by passing the mandatory assignments and hours online during and after school hours; the more hours put in, the quicker Summer School may be over. Once the teacher verifies that the student has completed a course, they are no longer required to attend class. **This will be communicated to both student and parent (do not assume).**
- Lack of significant progress or the inability to follow rules may result in the student being "inactivated" and **dropped from Summer School.**

With this model, **Motivation is the key!** Please do everything in your power to make sure your student puts in the time online.

I AM AWARE THAT:

- Teachers will support, guide and monitor my progress as I move independently through course requirements.

- I must complete all required coursework by the target date. If not, I may earn a 'No Mark' in the course.

- Logging on and working additional hours outside of my scheduled class/lab time and keeping up with my targeted completion percentage.

- Communicating with the teacher regarding any challenges I have with the assignments or the program.
- Abiding by the district technology acceptable use requirements.
