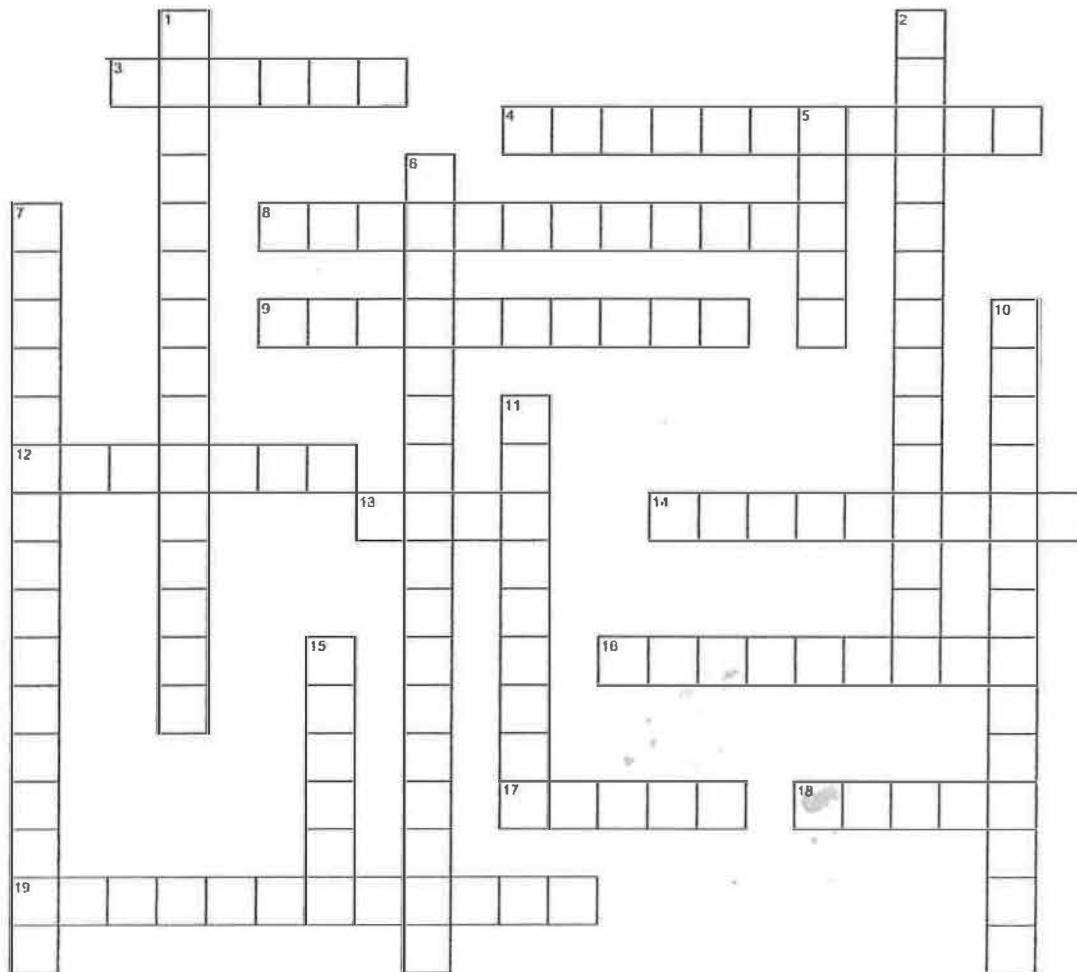

ACROSS

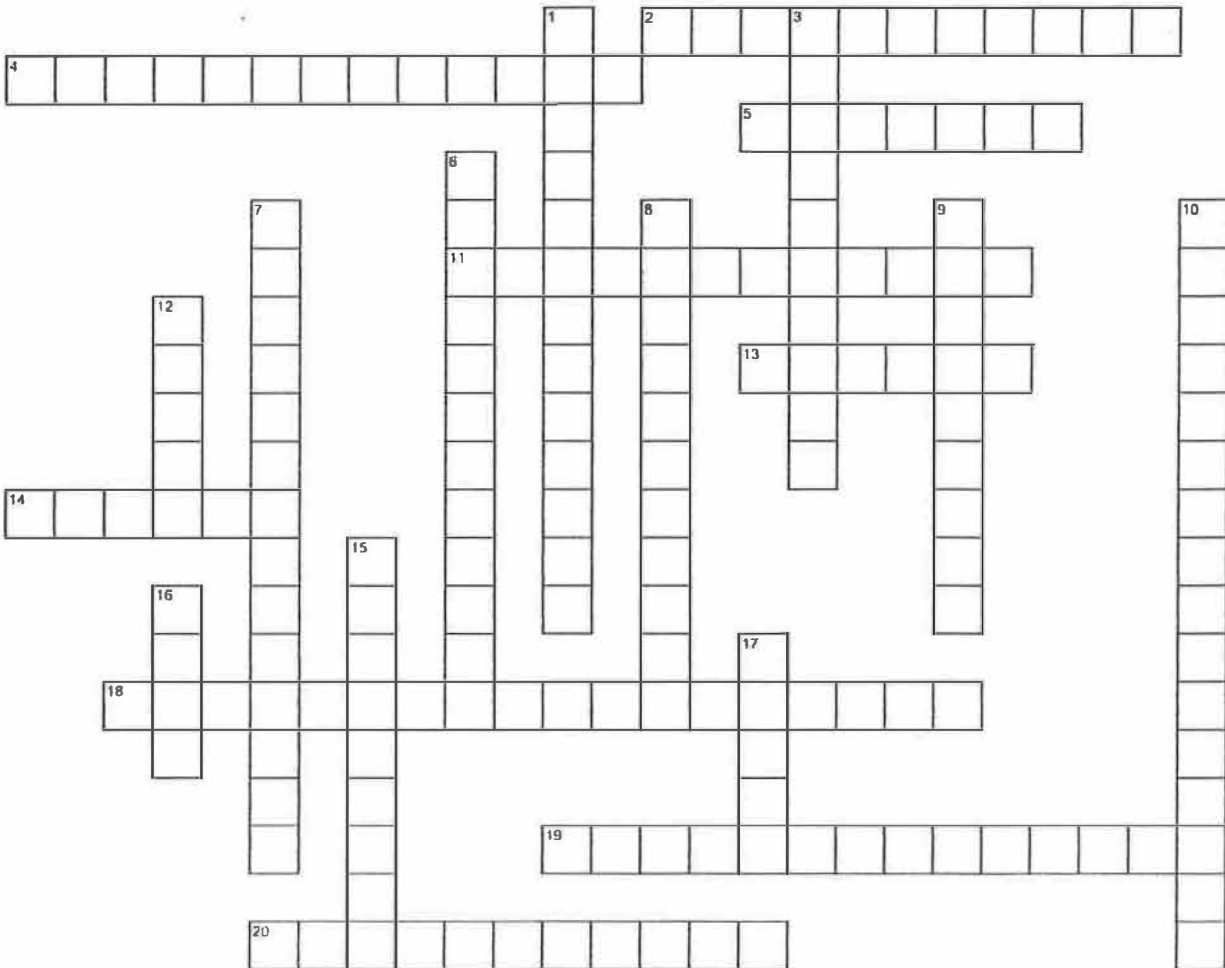
- 3 this body votes to confirm a justice after he or she is nominated by the president
- 4 interest groups will file these with the Supreme Court
- 8 this determines which court will decide a case
- 9 this person represents people accused of crimes
- 12 in order to remove a federal judge, Congress must vote to do this
- 13 number of justices on the Supreme Court
- 14 this act created a dual court system
- 16 in a civil trial, this party has the burden of proof
- 17 number of justices on an appeals court panel
- 18 this person is responsible for assigning a sentence to a convicted defendant
- 19 this court may send a case back to the lower court, reverse a previous decision or uphold a lower court decision. Decisions by this court must be honored by lower courts, serve as future precedent can be reversed and are supported by legal doctrine

DOWN

- 1 guilt beyond this must be determined in a criminal court
- 2 when the Supreme Court orders a lower court to send up records, its called this
- 5 in this type of trial, the judge decides the outcome
- 6 justices who agree with the minority write this
- 7 when judges loosely interpret the Constitution and make decisions that defend the rights of minorities
- 10 the appellate court looks for these when it decides to take a case
- 11 this person appoints federal judges
- 15 number of people on a jury

ACROSS

- 2 Petty theft, disturbing the peace and most traffic violations are this type of crime
- 4 evidence must be presented to a judge in order to obtain one of this
- 5 the jury is responsible for this
- 11 this rule says that evidence obtained illegally may not be used in trials
- 13 grand theft, armed assault and murder are this type of crime
- 14 testimony from eye witnesses is considered this type of evidence
- 18 in this case, the Supreme Court ruled that if a defendant could not afford an attorney, one would be provided for him or her
- 19 This court case said that school officials do not need a warrant to search students
- 20 the repayment to a victim from a defendant for losses, damages, or injuries resulting from a crime. It does not involve prison time

DOWN

- 1 if a defendant is sentenced to this, he or she spends time in prison
- 3 Procedures law enforcement is required to follow during the arrest and investigation of crime
- 6 the justice system allows for these because they reduce the number of trials a court must hold
- 7 Airport searches, student searches and these are considered legal without a search warrant
- 8 this person chairs the jury's deliberations
- 9 this group weighs evidence in felony cases and determines whether a trial is warranted
- 10 This court case said that defendants must be informed of their rights
- 12 this person sentences a defendant
- 15 these people provide key information to the jury
- 16 this guarantees that an accused will return for trial
- 17 a wrongful act that is done with intent
